

Standardization Zamboni Ice Resurface:

RESOLUTION STANDARDIZING ZAMBONI ICE RESURFACERS

At a regular meeting of the Town Board of the Town of Alexandria, held on May 18, 2022, the following resolution was adopted by the Town Board.

WHEREAS, the Town of Alexandria (Town) has an existing Zamboni brand ice resurface, and

WHEREAS, Town employees are experienced and trained in the operation, maintenance and repairs with such ice resurfaces, and

WHEREAS, the Town maintains a spare parts inventory necessary to complete immediate repairs to the ice resurface, and

WHEREAS, to purchase a different brand of ice resurface would be inefficient and uneconomical for the Town to operate.

NOW, THEREFORE, BE IT RESOLVED, as follows:

- 1. For reasons of efficiency, maintenance and economy and pursuant to the authority conferred by General Municipal Law Section 103(5), it is determined by the Town Board that there is a need for standardization in the purchase of ice resurfaces; and
- 2. The Supervisor is hereby authorized to contract for the purchase of additional ice resurfaces pursuant to the procurement policy adopted by the Town Board.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
